SETTLEMENT AGREEMENT

The Environmental Defense Fund, Trout Unlimited, and the Wilderness Society (plaintiffs); Robert N. Broadbent, Commissioner of Reclamation, James G. Watt, Secretary of the Interior (federal defendants); and Utah Power & Light Co. and the States of Arizona, Colorado, Nevada, and Wyoming (intervenor defendants), have determined that the best interest of all concerned would be served by an amicable resolution of this litigation. Accordingly, they agree to dismissal of this suit with prejudice and to the following terms.

1. Pursuant to the requirements of the National Environmental Policy Act, 42 U.S.C. 4321 *et seq.*, with regard to major Federal actions significantly affecting the quality of the human environment proposed by the Bureau of Reclamation in the Colorado River Basin, the federal defendants will prepare environmental impact statements (EISs).

2. The Bureau of Reclamation will consider in the scoping and preparation of the EISs the potential for cumulative and synergistic environmental impacts related to the proposal for federal action and to feasible alternatives to that proposal. Each future Colorado River Basin EIS prepared by the Bureau of Reclamation will contain an analysis of the cumulative and synergistic impacts, adequate to discuss and evaluate the impacts associated with the proposal and feasible alternatives to that proposal.
