THIS MATTER came on December 6, 2018 and the court being informed of the following:

That in Case No. 09CW144 Conditional Water Rights were issued for the above applicants for ENERGY FUELS PW-1 for 52 g.p.m. for industrial use including mineral processing, dust suppression, truck and equipment washing, fire protection and general maintenance, ENERGY FUELS PW-2 for 10 g.p.m. for industrial use including mineral processing, dust suppression, truck and equipment washing, fire protection and general maintenance ENERGY FUELS WELL FIELD for 80 g.p.m. for industrial use including mineral processing, dust suppression, truck and equipment washing, fire protection and general maintenance and ENERGY FUELS ZERO-DISCHARGE FACILITIES for 428 acre-feet for industrial use including mineral processing, dust suppression, truck and equipment washing, fire protection and general maintenance.


That the Court has jurisdiction over the subject matter of this action; that a mailing of notice of due diligence in accordance with rules and statutes was properly given; diligence was due by October, 2018.

That the Applicant(s) have not appeared or otherwise attempted to show cause why said Conditional Water Right should not be canceled.

WHEREFORE, IT IS THE ORDER OF THE COURT that the Conditional Water Right which is the subject of this action is deemed to be abandoned, and therefore, said right is hereby CANCELED.
