# ANSON RESOURCES: AUSTRALIAN COMPANY, LAS VEGAS OFFICES, UTAH ASPIRATIONS

Anson Resources: The Australian company is working via a series of shell companies in the Colorado River Plateau on a major lithium extraction and exportation effort that would require rights to about 11 billion gallons (30,000 afy) of Colorado River and Colorado River Tributary water each year. The company is engaging in Emery, Wayne and Grand County at sites along the Colorado River, Green River and near Fremont River/Hanksville -- an effort known as its Paradox Project.

It aims to conduct Direct Lithium Extraction projects via proprietary technology that has no track record at any operating lithium mine in the United States.

**Considerations:** Applications filed to drill up to 10,000 feet deep via unproven technology. PODs right near the Colorado River. PODs and POUs on SITLA land. Proximity to Canyonlands NP and Deadhorse SP





Investor reports show that they have a plan to pump and pipe water across the canyons near canyonlands and Dead Horse State Park.

This would be a major undertaking for which the company does not yet have approval.

SUWA stopped an exploratory EA in the NEPA process.





Figure 5: Paradox Lithium Project Infrastructure.

Filed on: July 17, 2023

Protested: BOR, Gayna Salinas, GBWN, Living Rivers

CFS: 19 cfs /13,755 afy (Says non-consumptive but no proof).

Considerations: City Council Member sold land to Anson, uranium, existing water rights, downstream users



# Wayne County Water Conservancy District:

**Filed On:** Change apps will need to be filed. Water lease executed earlier this year

**AFY:** 2500 afy

**Considerations:** The water Anson leased is from PODs in different water rights areas that proposed extraction sites. These are interbasin transfers if executed for Green River, which is what was implied at a recent meeting. Hanksville potential target of processing facility. Though company says that want a facility in Green River.
