It has been brought to our attention that there are a couple of errors that we made regarding the points the diversion and we hereby request that they be corrected as soon as possible so interested parties may review the corrected points. The requested corrections are as outlined below and the referenced point of diversion numbers are from the Division's database.

Point of Diversion Number 5 currently is shown as being located at a point N 1300 ft E 1050 ft from the SE Corner, Sec 25, T27S, R22E; Change it to be N 1300 ft W 1050 ft from the SE Corner, Sec 25, T27S, R22E (Well No. 21A).

Point of Diversion Number 16 currently is shown as being located at a point S 1300 ft E 1100 ft from NW Corner, Sec 08, T27S R23E; Change it to be N 2500 ft W 2200 ft from the SE Corner, Sec 08, T27S, R23E (Well No. 13D).

Please delete Point of Diversion Number 21 which is shown as being located at a point S 2500 ft E 2200 ft from the NW Corner, Sec 30, T27S, R23E (Well No. 20A). This POD is located on BLM property and the applicant does not want to develop a well at this location.

We believe these minor corrections do not materially modify the application and the potential affect on the hydrologic system is not measurably different. Therefore, we would respectively request that the State Engineer address these corrections in your Order.
